I have held off scheduling a meeting of the Council pending appointments of new members. We now have a full complement with the exception of one district court judge. I anticipate that that appointment will be made within a week. I understand that the new circuit court members have not had their appointments ratified but, assuming ratification, have included them as members for purposes of this mailing.

First, let me welcome the new members of the Council. Unfortunately, with terms expiring in 1985, we lost the Council Chairman, the Vice-Chairman, and the Treasurer. The first order of business at the November 23 (or December 14) meeting will be to elect officers to preside over Council proceedings during the next biennium.

Since the Council submitted its December 8, 1984 report to the legislature, a number of issues have arisen regarding the Oregon Rules of Civil Procedure which will require Council attention. Accompanying this memorandum are copies of suggestions which I have received. In addition to these suggestions, the 1985-87 biennium provides the Council an opportunity to do a review of the ORCP for purposes of correcting errors, ambiguities, or practices which hamper, rather than assist, the administration of justice.

Since this memorandum does provide rather short notice, I would appreciate it if each of you would return the form at the end of this memo indicating your ability to attend the November 23 meeting. If it is impossible to have a quorum on that date, I am suggesting a tentative alternate date of December 14, 1985. The sooner we can project attendance, the sooner we can confirm the date of the meeting. Your prompt reply would be appreciated.
